<u>Multi-County New Landowner Educational Series Continues –</u> October 17th – 2 CEUs

The October program of the Multi-County New Landowners Educational Series will focus on fence building and equipment demonstrations. The program is set for Friday, October 17, 2014 at the Washington County Fairgrounds VIP Building at 1305 E Blue Bell Road in Brenham, Texas. This session will feature a classroom presentation on fencing options, basic fencing techniques, and provide several hands-on demonstrations. The event will begin at 1:00 with registration and the program to follow. The standard registration fee of \$20 applies and can be paid at the door.

This October session is sure to be a dynamic and interesting session that will have value to landowners who are interested in or are in the process of making renovations to existing fences and considering putting up new fences. The Multi-County New Landowner Education program is a series of 9 informational meetings, seminars, and field days designed to make new landowners in Austin, Colorado, Fayette, & Washington Counties aware of what types of agricultural enterprises are best for their property. Participants in the program will hear from experts in certain fields of agriculture about the best management practices that they can implement on their own property. This innovative program assists new landowners in understanding the concepts of rural living. Participants in the program are given exposure to ideas on raising livestock and horses, plant identification, fence building, applying pesticides, soil testing, stock pond management, pond construction, fruit and nut production, and much more. The program also serves as a way for new residents of the four

counties to network and meet new people in their communities, find out what can be done on their land, what operations can be profitable, and possibly what opportunities they have to serve the community.

The program is held on the third Friday of the months of January through May and August through November. Each month's meeting will be held at different locations in one of the four counties. The meetings begin at 1:30 pm. And will last between 4 and 5 hours depending on the topic and possible tour stops. The cost for the program series is \$100.00 per person or \$150.00 per couple for all nine meetings or \$20.00 per person per meeting. CEU's for pesticide applicators will be offered as they are applicable, and refreshments will be served at each program session. <u>South Central Texas Cow/Calf Clinic – Washington County</u> <u>Fairgrounds – October 24, 2014</u>

The 43rd Annual South Central Texas Cow-Calf Clinic and Trade Show will be held on **Friday**, **October 24**, **2014** at the Washington County Fairgrounds Sales Facility in Brenham. Registration fee is \$20.00 per person, and registration will be from 7:15 am until 8:00 am. All area producers are encouraged to attend to receive information which will help them make sound management decisions in their beef cattle operations.

A great list of speakers has been prepared for you based on the recommendations of the area Beef and Forage Committee members from Austin, Brazos, Burleson, Fayette, Grimes, Harris, Lee, Waller, and Washington Counties. Dr. Jason Cleere and Doug Pierce will start the morning session with a presentation and demonstration on heifer selection and evaluation using a variety of breeds to look at. Dr. Steve Hammack will follow up their demonstration with a reminder about the basics of breed characteristics for the cattle in our area. After the conclusion of the genetics session we will turn the focus to the economics of buying vs raising replacement heifers with Dr. Levi Russell. Moving down the program we will transition to discussion on weed and brush control and fence line management with Jack LeClair and finally wrap up the series with a fencing demonstration by StaTite50, The 50 Year Fence.

Each year the Cow Calf Clinic is supported by numerous sponsors and trade show vendors who will have booths, equipment displays, and representatives on had to visit with participants throughout the day. This year the Cow Calf Clinic is opening up the trade show to cattlemen that would like to bring in bulls or heifers for display. The guest speakers and program topics include: "Farm Service Agency General Overview" – Grady Kelley, DeWitt/Karnes FSA Director; "Explanation of Relevant Changes to Ag Policy in the 2014 Farm Bill" – Dr. Levi Russell, Extension Economist; and "Demonstration of the Texas A&M AFPC Decision Aid" – Mac Young, Extension Program Specialist. This part of the program will demonstrate the online decision-making tools that are available to producers to help make important enrollment decisions regarding the Agricultural Risk Coverage (ARC) and Price Loss Coverage (PLC) programs. Learning more about ARC and PLC is extremely important for producers who must make a one-time decision about base and yield updates as well as ARC or PLC election and enrollment decisions. The Extension Specialists and FSA Director will be able to answer any questions on ARC and PLC policy and procedure.
